# To the Alumni and Ex-Students of Swarthmore College.

DEAR FRIENDS:

Every man who has ever trained in the old wooden "Gym" has looked forward to the time when a good modern, adequately equipped building, dedicated to the physical culture of young men, should adorn the campus at Swarthmore. This desire is now, we hope, about to be realized. All that is needed is that each Swarthmore man and woman should contribute, not perhaps what his warm good wishes for his *Alma Mater* would prompt, but simply what he can.

As most Swarthmore people know, this project was broached four years ago, but in view of the deep business depression throughout the country, it was deemed wiser to wait for a brighter day. That day we think is now dawning. We need, therefore, only the united effort of the friends of the College to secure this long-desired improvement.

The amount to be raised is fixed at \$15,000. This will erect the building represented by the accompanying cuts, finishing all in good shape except perhaps some parts of the basement. The Committee have already received a number of \$100 subscriptions, and desire to have as many more such as possible. To those not able to contribute this amount sums of seventy-five, fifty, twenty-five, fifteen, ten, or even five dollars will be most heartily welcome. It is important that everybody should do something.

It will be noticed that subscriptions are made payable Fifth month 1st, 1898, provided the entire amount is guaranteed. We hope to lay the corner-stone at Commencement time, Sixth month 14th, 1898.





### To the Alumni of Swarthmore College.

Twenty-seven graduating classes have gone out from the College, and the Alumni has grown to be a body considerable in numbers and including in its ranks men and women now approaching middle life, many of whom are successful in business, and all of whom, it is believed, cherish a warm feeling for their Alma Mater, and a desire to aid her in a career of usefulness and honor, which is measurably reflected upon every member of her Alumni.

The College has, ever since its foundation, been managed with great care; otherwise, with its insufficient endowment, it would long ago have been in financial straits and unable to perform its work successfully. But expenses cannot be reduced beyond a certain point without impairing the efficiency of the college work, and can never be met by the income from tuition alone.

This condition is not peculiar to Swarthmore, but it exists in all progressive colleges, especially in those which are not heavily endowed. As an illustration, Haverford College, under conditions somewhat similar to ours, several years ago had an accumulated deficiency of about \$50,000, and was rapidly running behind year after year. In this serious strait, seven Friends of their body agreed to contribute each \$2,500 per year for five years, making an aggregate of \$17,500 yearly, which action tided the College over until the receipts from the income of the new endowment of about \$1,000,000 began to be received.

It is proposed to meet the present urgent needs of Swarthmore in a similar way. The sum of \$12,500, which should be raised yearly, is to be divided into five portions of \$2,500 each. Two Friends have agreed to become responsible for two portions, or \$2,500 each annually for five years, on the condition that the whole amount be raised; and it is hoped, if the Alumni will arrange among their number to take care of one portion, that with this arrangement the remaining two portions may be raised by the Board of Managers.

As the number of wealthy Friends is few, it will be difficult and almost impossible to do this without the active co-operation of the Alumni in the way indicated. But with the interest of the children of the College assured, others will be more willing to extend a helping hand.

The contributions for the college year 1900-1901 need not be paid until Fourth month of 1901; and the same month may be set for the payments of the four following years; but it is of the highest importance that the whole amount be promptly pledged in order to secure the amounts promised conditionally, and to rescue our Alma Mater from real difficulty.

#### DIRECTORS CONFER

The Officials Refuse to Discuss the Project, but It is Generally Believed That the Deal Will be Made-Francis B. Reeves for President.

It was rumored on 3d street yesterday that everything had practically been com-pleted for the consolidation of the Indapendence and Girard National Banks, the former merging into the latter. It was said on good authority that Francis B. Reeves, President of the Girard National Bank, will be President of the consolidation, and that Richard L. Austin, President of the Independence National Bank, Vice-President, J. G. Whiteman, cashler of the Girard, will probably retire, and Theo-dore E. Wiedersheim will become cashier of the consolidation.

The original intention of the promoters of the project was to bring the Girard National Bank up to the Independence, but since the Stock Exchange decided to locate at 3d and Walnut streets, the order has been reversed, and the historia old structure on 3d street, built in 1703, on the plan of a Corinthian Temple, will be the home of the new concern.

The building now occupied by the Inde-pendence National Bank sandwiched in between the two front wings of the Drexel Building, will, undoubtedly, be purchased by the Drexel estate. By doing this the splendid white marble structure may be given an unbroken front on Chestnut street, and the eyesore, which annoyed the late A. J. Drexel, incessantly, re-

The old expression of monarchical rule, the arbitrary "sic volo, sic jubeo," has largely given way to the new dictum, "The King reigns, but does not rule." Lincoln's emancipation proclamation was delayed until it had obviously become the will of the people. In like manner McKinley delayed as long as possible the unavoidable recent war with Spain.

We do not find in the great community of nations such common agreement in favor of international law compelling arbitration as naturally precedes the making of a law in the smaller community of a town or a single nation; apparently much deliberation must precede the formation of such a public opinion. If it were possible for the nations now to make a compact binding them all to submit all questions between them to a tribunal of arbitration, that compact would prove absolutely worthless in the case of any really vital dispute between two nations of approximately equal power. Besides, if the award of the tribunal is not to be enforced, it is palpably futile; if it is sufforced war follows, which is the thing to be avoided. We must not expect one class of laws to We must not expect one class of laws to rule in the sphere of another class, though they may be concurrent.




